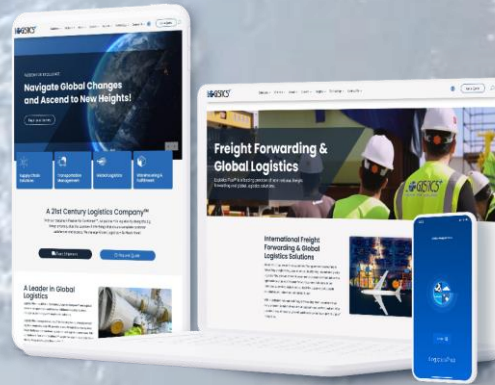

Jim Berlin founded Logistics Plus, Inc. in 1996 with only three employees, one customer and a \$120,000 purchase order from our first customer, GE Transportation.

Today, the company has over \$600M in global revenues, 1,200 employees, and thousands of customers.

Jim Berlin, Founder & CEO



After a 20-year career in the less-than-truckload (LTL) industry, most of that time spent at TNT/USF Red Star, Jim founded Logistics Plus in 1996 with only three employees, one customer, and a \$120,000 purchase order. Though he is a New York City native, Jim has invested heavily in the community's economic development since relocating to Erie, PA. In 2003, he renovated the 80-year-old former train station and made it the company's global headquarters, and he actively participates in many civic initiatives. In addition to many company awards, Jim has been honored as a Most Admired CEO by the Manufacturer and Business Association (MBA), and Ernst & Young (EY) recognized Jim as Western Pennsylvania's "Entrepreneur of the Year" in 2004. In 2005 he was named to the lifelong EY Entrepreneur of the Year World Hall of Fame. In addition to his company and community activities, Jim is also a member of the Business Advisory Council for the Federal Reserve Bank of Cleveland.

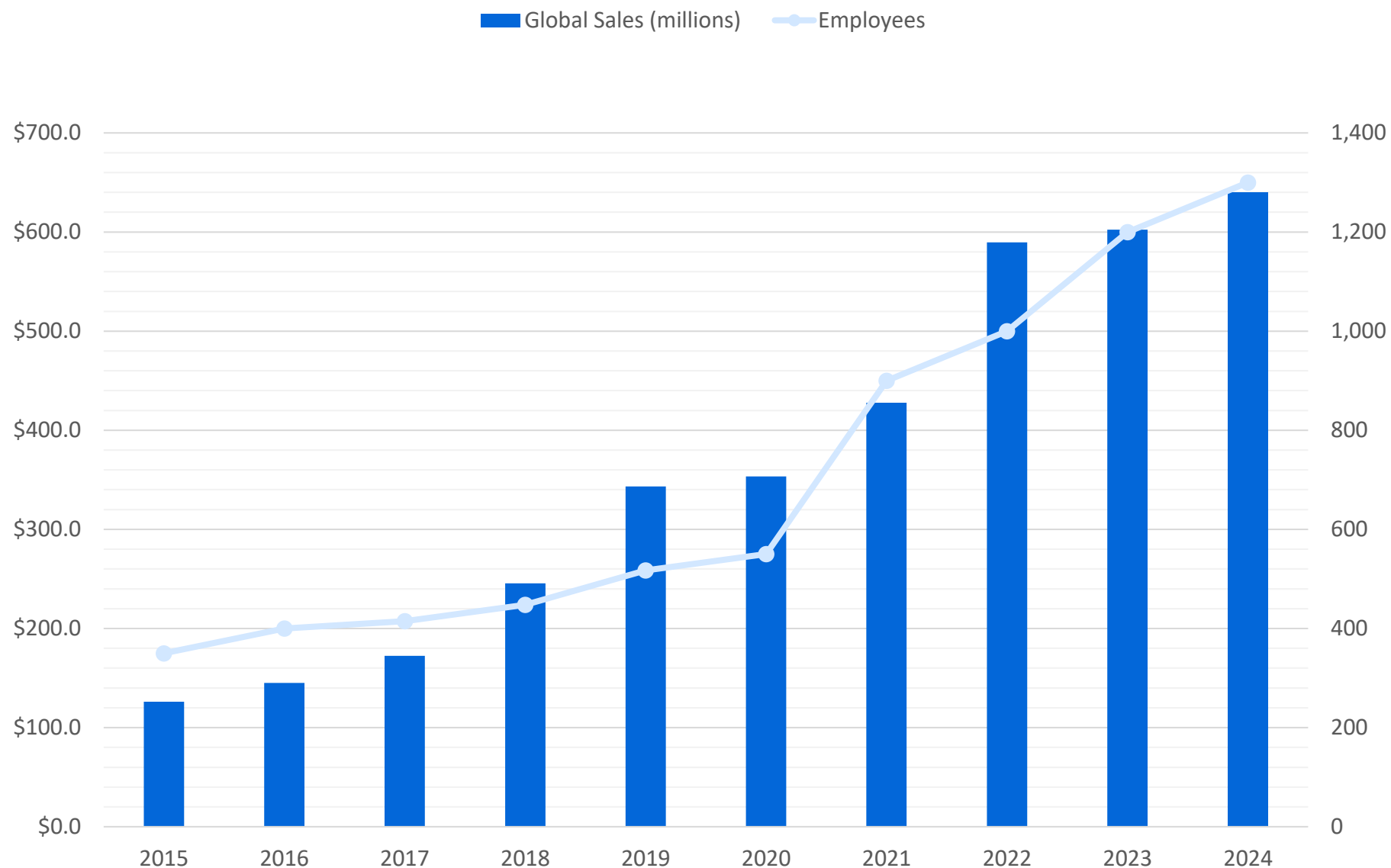

We Continue to Adapt to Change



1996

Logistics Plus is founded by Jim Berlin when he was given a one-year, three-person purchase order for \$120,000 to manage inbound logistics for GE Transportation (now Wabtec Corp.)



2001

The Logistics Plus team heroically rallies after 9/11 by coordinating the first air charter from Europe to the U.S. post-attack to keep our clients supply line running.



2011

Logistics Plus acquires Horizon Logistics, with offices in Texas, North Carolina, and California, adding additional freight forwarding and solar industry experience to the company.



2016

Logistics Plus on-boards WeWork as a global client. LP would build out a global FF&E network that helped WeWork open almost 2,000 new offices in 30 countries within four years.



2018

After a successful pilot program in the U.S., Google signs Logistics Plus to a long-term global contract to help bring its consumer products (Pixel, Nest, Speakers) to global markets.



2020

The LP Medical division is formed at the start of the COVID pandemic to source, warehouse, and distribute millions of pieces of PPE to organizations worldwide.



2023

Logistics Plus acquires Netherlands-based company Jan Krediet to expand its European footprint and operations. Jan Krediet was founded in 1924.



2024

Logistics Plus CEO Jim Berlin is one of eighteen business leaders in the World named to a special Business Advisory Council (BAC) to support Ukraine's economic stability and future growth.
